Our Commitments

Olive Building Contractors Ltd will, so far as is reasonably practicable:

1. Reduce Resource Consumption

Minimise energy use and improve efficiency across all operations.

Source utilities, equipment and consumables from responsible suppliers who support sustainability and renewable energy where possible.

2. Minimise Waste & Promote Recycling

Reduce waste at source through careful planning and material management.

Reuse and recycle materials, equipment and packaging wherever practicable.

Segregate waste in accordance with UK waste regulations and site waste management procedures.

3. Manage Hazardous Substances Safely

Use, store, transport and dispose of hazardous materials in compliance with environmental law, COSHH, and industry best practice.

Prevent spills, contamination and environmental harm through robust control measures.

4. Prevent Pollution

Take all reasonable steps to prevent pollution to air, land or water.

Use spill kits, barriers and controls to prevent run-off and drain contamination.

Select materials, equipment and processes that have reduced environmental impact.

5. Work With Responsible Providers

Prefer suppliers, subcontractors and service providers who demonstrate strong environmental standards.

Engage with waste carriers who hold valid waste carrier licences and provide compliant Waste Transfer Notes.

6. Consultation & Communication

Consult with workers and subcontractors on environmental matters, including through safety and environmental meetings.

Ensure everyone is aware of their environmental duties and control measures.

7. Continuous Improvement (ISO 14001 Principles)

Set measurable environmental objectives each year and monitor progress.

Review our performance regularly to identify opportunities for improvement.

Maintain and continually enhance our environmental management practices.

8. Annual Review

This policy and all environmental procedures will be reviewed annually—or sooner if legislation or operational needs change.

Worker Responsibilities

All workers and subcontractors must:

- Follow this policy and any environmental procedures or instructions issued on site.
- Segregate waste correctly and prevent pollution.
- Report environmental incidents, spills or concerns immediately.
- Make a positive contribution to protecting the environment through responsible behaviour and good site practice.
